



**Dear Businesses Owner,**

Re: New State Recycling Requirement for Businesses & Multifamily Dwellings

We are contacting you to help you comply with a new State law. California Assembly Bill (AB) 341 requires all businesses that generate four (4) or more cubic yards of waste per week to recycle. The law also applies to multifamily dwellings of five (5) units or more, regardless of the amount of waste generated.

Businesses and multifamily dwellings are required to separate recyclable materials from their solid waste and either allow the pick up of recyclables or self-haul. Your recycling program must be in place by July 1, 2012 in order to comply with State law.


### SSSFSC provides other recycling services for a fee:
