SERVICE INFORMATION

Garbage and organics collection are provided for a fee. Current rates are available on our website or by contacting our office. Properly sorted recyclables are collected at no additional charge for customers who maintain regular weekly garbage service. Collection is available up to five days per week (Monday–Friday), with Saturday service available for businesses needing six-day pickup. Customers generating large volumes of waste may request roll-off boxes or compactors for more efficient collection.

GARBAGE

GARBAGE: any non-hazardous trash that does not belong in the recycling or organics cart/bin. Cart & Bin Sizes available:

- Cart: 32, 64, or 96 gallon
- Bin: 1, 2, 3, 4, 5 or 6 cubic yard



RECYCLE

RECYCLABLES: paper, cardboard and containers are collected separately and require 3 separate carts/bins. Cart & Bin Sizes available:

- Cart: 96 gallon
- Bin: 1, 2, 3, 4, 5 or 6 cubic yard



ORGANICS

ORGANICS: yard trimmings, food scraps, and food-soiled paper should be put into your organics cart/bin. Cart & Bin Sizes available:

- Cart: 32 or 64 gallon
- Bin: 1, 2, 3, or 4 cubic yard



STATE & CITY REQUIREMENTS

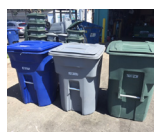
State and local laws require all properties to:

- Subscribe to weekly recycling, organics, and garbage service with bins sized for your waste.
- Check bins twice a year for contamination and remind tenants/employees how to sort correctly.
- Share sorting instructions with employees and tenants within 14 days of move-in and at least once per year.
- Place recycling and organics bins wherever garbage bins are provided (except restrooms). Label bins clearly using standard colors: blue = recycling, green = organics, gray/black = garbage.

SERVICE RESTRICTIONS

- Heavy materials (dirt, rock, concrete, sod, brick, tile) cannot go in carts or bins. Request a 7-cubic-yard roll-off box for these items.
- Yard trimmings belong in an organics cart, bin, or roll-off box. Cut branches and stumps to under 6" thick and 3' long.
- Electronics require special handling—contact our office for assistance.
- Hazardous materials such as auto parts, tires, batteries, chemicals, paints, treated wood, sharps, and fluorescent lamps are not accepted in any collection container. CONTAINER MAINTENANCE

Your garbage, recycling, and organics bins are built for long-term use. Customers are responsible for keeping bins reasonably clean, while we handle repairs or replacements as needed. If a bin leaks, has damaged or missing parts, or needs a new label, please contact us. Steam cleaning is available upon request (fees apply).

UNAUTHORIZED USE OF COLLECTION BINS

Keep collection bins inside a locked enclosure or secure individual bins with locks to help prevent unauthorized dumping or removal of recyclables. You may use your own combination lock (please provide us with the code) or purchase one from us. Please contact our office to make arrangements.

COLLECTION DAY CHECKLIST

- Place all materials in the correct bins with lids closed.
- Keep the area clean and accessible.
- Check sorting and don't block access—extra fees may apply for us to return.
- Need help with overflow, e-waste, or bulky items? Contact us.

RECYCLING TIPS

Each recycling container is labeled with examples of accepted materials. For more details, visit ssfscavenger.com/sort-smart. Remember to:

- Flatten dry cardboard
- Put waxed cardboard in garbage and food-soiled paper in organics
- Scrape and rinse food and drink containers
- Contain shredded paper in a sealed paper bag
- Place recyclables loose—no liner bags

ORGANICS TIPS

- Put plastic and plastic-coated items in garbage—including those labeled as compostable or biodegradable
- Place only food scraps, food-soiled paper, and yard trimmings in the green bin

Upon request, our outreach team can provide training for your staff or tenants. We'll evaluate your waste practices and offer recommendations to reduce waste, improve recycling and composting, and ensure compliance with state and local requirements.
